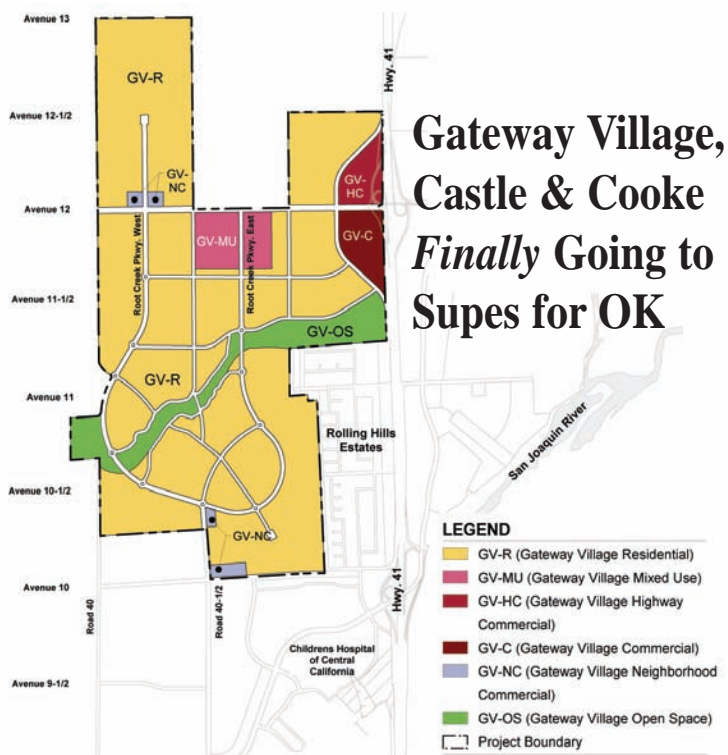

Gateway Village, Castle & Cooke Finally Going to Supes for OK

On Tuesday evening, May 22, Castle & Cooke's Gateway Village project and Environmental Impact Report won unanimous approval by the Madera County Planning Commission. Next up is the Board of Supervisors public hearing, scheduled for Tuesday, Aug. 14 at 10 a.m. at the board chamber of the new Madera County Government Center on 4th street in the City of Madera.

After years in the planning process, Castle & Cooke's Gateway Village project may finally be positioned to break ground in the coming months. On Tuesday, Aug. 14, the project will be heard by the Madera County Board of Supervisors. Up for consideration by the Board of Supervisors are the Area Plan, Specific Plan, Infrastructure Master Plan, Development Agreement, and Environmental Impact Report (EIR).

Gateway Village, located

just west of Highway 41 between Avenues 10 and 12, plans to provide 6,578 new residential units, along with more than 2,000,000 square feet of retail, commercial, school and public uses within its 2,000 acre boundary. The Village of Gateway is a "neo-traditional" or "new-urbanist" plan that incorporates a broad array of residential product types along with commercial, retail, schools and mixed-use products that are connected by

a system of roads, trails, parks and open space. One of the goals of the plan is to encourage pedestrian and bicycle transportation.

A key element of neo-traditional planning is that community activity "nodes" (shopping, schools, work, recreation) are located a maximum 10 to 15 minute walk from residential neighborhoods. This design feature will, for instance, allow students who reside in Gateway Village to walk or bike to school, in lieu of riding the bus. It also means that residents of Gateway will be able to walk to the store to shop, or in some cases, walk or bike to work. There are approximately 200 acres of parks and open space and more than nine miles of community trails that help link the community.

Two areas of primary interest to the Ranchos community are Gateway's provision of water and new schools. Through a series of agreements, Gateway Village will

TRAGEDY IN THE RANCHOS



A single pistachio tree on Road 38 has become a makeshift shrine marking where 16-year-old Donovan Tessmer lost his life in an accident involving five Ranchos teens early Sunday morning on July 8.

At approximately 1:30 a.m. on Sunday, July 8 on Road 38 just south of Avenue 12, a group of five teenagers travelling at speeds estimated at nearly 90 miles per hour, slammed into a pistachio tree, killing 16-year-old Donovan Tessmer and seriously injuring driver Danica Lacy, 16, and passenger Gavin Knobloch, 15. Two other passengers, 17-year-old Alexandria Rodriguez and Dustin "Missouri" Simpson, 16, received only minor injuries.

Based on conversations with parties close to those involved in the accident, the five were returning home from a night of movies at River Park in Fresno. Rather than come home down Avenue 12, they elected to take Avenue 9 to Road 38 where they turned north toward Avenue 12 and the

Ranchos.

Road 38, although relatively straight, has a series of undulations that when driven over at a high rate of speed can cause a car to get airborne and create a sensation of weightlessness. This sensation is heightened when no seat belt is worn, allowing the rider to actually become weightless and momentarily "float" in the car. It is assumed that this is what the three boys in the back seat were attempting, explaining why none of them had seat belts on.

When the car lost control and the driver's side of the 2005 Toyota Corolla slid into the pistachio tree, all three unrestrained passengers in the back seat were ejected from the car, killing Tessmer immediately and severely injuring Knobloch. Being at the point of impact with the tree, driver Lacy also received major

injuries although she was wearing her seat belt. Emergency crews arrived quickly as the result of a 911 call made by Rodriguez.

Knobloch and Lacy remain hospitalized as of press time. Tessmer received a Memorial service at Liberty High School on Monday, July 9 (see pictures of the event on page 2) and then had a full funeral service at Northpoint Church in Clovis on Friday, July 13. Tessmer's family elected to cremate his remains.

The Golden Valley Unified School District has established a memorial scholarship fund in Tessmer's name to benefit a future graduate of Liberty High School. Tessmer maintained a 3.8 grade point average in addition to excelling at sports and had received letters of interest from 25 colleges regarding his skill in football.

A car wash, donation bucket and BBQ will be held on Saturday, July 28th at 9 a.m. in the parking area of Madera Rancho's Market.

Many of our Liberty High and Rancho's Middle School students are offering their energy and time to wash cars or offer a tri-tip sandwich to support the Knoblochs.

The community is invited to share their continued support and stop by for a car wash, BBQ or donation.

what you would have done in that situation? Hopefully we will all never have the opportunity to find out. What Alex did, at her age, with what was happening around her, I cannot fathom what was going through her mind. I just hope that this tragedy will not go in vain. We need kids, everyone, to be award of speed limits, speed laws. They are not out there to just bug you, frustrate you or to make you drive like a grandma. There are reasons why laws are there. People just need to take their time, put their seatbelts on and use some simple common sense.

Goodbye, Donovan

This is without a doubt one of the hardest papers I've ever had to put out. The images of Donovan Tessmer just rip my heart out. He's only a kid. Kid's don't die. Old people die. That's how it's supposed to work. That's how it always works.

But not this time.

I didn't really know Donovan, but I knew of him. That's pretty impressive when you're a 16-year-old kid and adults know of you. Adults usually know about this kid or that kid because of all the wrong reasons; but that wasn't the case with Donovan.

He truly was an inspired football player. It was great watching him run with the ball. This was the year he was going to come into his own. He was going to own defensive lines and chew up and spit out linebackers. According to his coach, over 25 colleges had expressed an interest in him. And why wouldn't they? In addition to his mad football skills he was also maintaining a 3.89 G.P.A., the highest on the team. These are all reasons why adults know of that 16-year-old Tessmer kid - they wished he was *their* kid.

I know his mom, Martha. We were on the Site Council together at Sierra View. She was a fixture at Sierra View, volunteering, picking up the kids, doing whatever. I think that every day, without fail, when I would go to Sierra View to pick up my kids, there would be Martha.

My oldest daughter is five months younger than Donovan so that was enough for them to be separated by a year in school, but that wasn't enough to keep her from knowing who Donovan was. He truly was one of those kids that all the girls adored, but the guys liked him too.

He was a buddy. He was a good kid, a good son, a good student, a good athlete, a good friend.

How do I know all this? Because it was written all over the faces of those kids and adults at the memorial service and then again at the funeral. Here was a life whose actions spoke louder than words.

Maybe I'm taking it so hard because my daughter is the same age and I'm projecting this all on her. What if it would have been her in that accident? What if I would have gotten that call at 1:30 in the morning? Thinking about it kills me. I cannot imagine how hard this would be to endure. I have absolutely no frame of reference to pretend to know the level of hurt the Tessmers are experiencing.

But I do know they have strong faith in God and it is helping them get through this. I also know that they have the assurance that they will see Donovan again one day, and I'm sure that the comfort of that knowledge is priceless.

My favorite Donovan story has to do with my wife. She's a bigger football fanatic than I am and knew all the Liberty players on sight. I remember her commenting on more than one occasion about what a cutie that Donovan Tessmer was. One day she was over at the school picking up my daughters after school and while she was waiting she saw Donovan getting on the bus to go home. When my daughters got in the car she turned to them as if they had absolutely lost their minds. "You guys want to ride with ME when you could be on the bus riding with Donovan??? Are you all nuts???" In unison my girls gave the only response girls that age have: "Mommmy!!!"

Goodbye, Donovan. You didn't know it but you were blessed with a wonderful gift: You made people glad they knew you.

It sure seems like school just let out but in less than a month a new school year starts up again. Where does the time go?

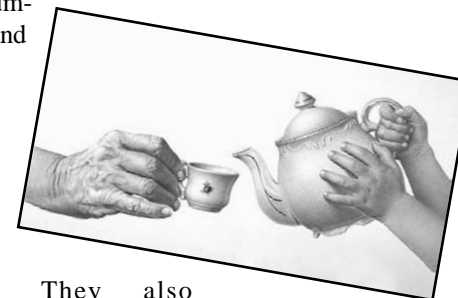



While digging into how the County has spent the millions of dollars in fire mitigation money that has been collected from 1992 to today, I found another bone that needs to be dug up and checked out. I am finding way too many things that need to be looked at and just do not have the time or money to do them all, so I will be plugging along with what I can handle.

It seems that the Army Corps of Engineers has been paying Madera County well over \$100,000 per year to maintain the levy system in the county. The total comes to around \$2.7 million.

PROBLEM: *Madera County has not been doing the work on the levies.*

Now our levies are in such bad condition that the Feds are about to decertify the whole system – all 75 miles of levies in the county. What that means to the taxpayer is if you live anywhere near any of the levies, or in an area that a failure would affect you, you will need some very expensive flood insurance. On the other hand, if one of the levies that Madera County had been paid to maintain for all of these years were to break or fail I would imagine the county (we taxpayers) would be liable.

This looks like to be – at best – another case of “... rob Peter to pay Paul;” and at worst somebody had their hand in the till. Either way we are going to get stuck with the bill to clean up the mess caused by yet another dropped ball. My question is how many of these little ticking time bombs are out there waiting to be discovered?

I read in the Madera Tribune recently that Madera has a “COMMERCE TRIPLE-PLAY” about to happen. Three major developments all soon to begin. It seems that Madera City is giving the developer a pass on a lot of the normal fees – to the tune of many millions of dollars worth. In the paraphrased words of one of the City Council members, “... we've given away way too much – we're giving away the farm.” Six months ago Madera City was in need of our \$3.2 million of Measure “A” money. I am sure glad we were able to help *them* out so they could help out *their* developers so much.

PROBLEM: *Madera County just passed an ordinance slamming development fees on everybody that builds, but the last I heard the cities of Madera and Chowchilla had not adopted the plan for their areas.*

The new development fees do not have to be spent in the area that is being developed or where the fees are collected. “They will be spent where the need is the greatest,” said Ray Beach, Planning Director for the Madera County Planning Department. I believe as it is written the money could even be given to either of the cities of Madera or Chowchilla, even though they are not willing to have developers in their cities pay into the pot.

We built our new Government Center in the middle of the city of Madera and it is a real pain to get in and out of there with no traffic lights to help you once you leave the parking garage. Why didn't we build the Center of our County Government

What's New or What Now?

Will it ever end? Or is the question, “Will they ever begin?”

In the ever-changing world of California environmental politics, you can always count on the fact that some bright young bureaucrat in some state or federal agency in Sacramento will cook up some new environmental headache for property owners to deal with. These “ideas” usually take the form of new regulations that, in effect, either limit what you can do on your property or prevent you from doing anything at all.

Now, I recognize that we all have a responsibility to be good stewards of the environment in which we live. I am an advocate of taking a reasoned approach – based on sound science – to solving problems involving environmental safeguards. After all, we have to make sure that our homes and our communities are sustainable. Without sound planning, we run the risk of spoiling our communities both for ourselves and for our children.

Where I have a bone to pick, however, is when certain individuals (see “bright young bureaucrats” above and the lawyers who support them) place the ever-changing “needs” of the environment above the needs of the people who reside in that environment. I believe that God created the world to be both a home and a resource for

mankind.

Here in California, the problem is getting worse. I thought, at first, that it would be a good thing when Arnold Schwarzenegger took over from Grey Davis. At first, it looked promising, but early on our new governor sold out to the radical environmental left. The Terminator allowed Robert F. Kennedy, Jr. and his pals at the Natural Resources Defense Council (NRDC) to call the shots on environmental policy in the state. Yes, it's the same NRDC that fought with the Friant Water Users Authority for years over the waters of the San Joaquin River. Yes, it's the same NRDC that proposes to put Salmon back in miles of riverbed that has been bone dry for decades.

Under our current governor, radical environmentalists have assumed leadership positions in most all of the important environmental agencies in the state. Most of the agencies you've never even heard of. It's a Pandora's Box of acronyms. The problem is, these acronyms have an incredible amount of power to change the way you live.

One of the environmentalists' favorite play-toys is the Endangered Species Act (ESA). This law allows

Dear Editor:

As a 28-year resident of the Bonadelle North subdivision, I want to share my reasons for opposing Superstition Builders, Inc. request for placement of a proposed strip mall at Avenue 15 and Road 36.

The County Master Plan calls for Avenue 12 to be the civic center of the Ranchos. "Leap frog" development = poor land management and leads to visual blight and poorly planned communities. Industrial use such as mechanic shops should be located in an area zoned for industrial purposes, not in residential backyards.

Time and again the best places to live not only have wonderful people, but also have visual or aesthetic appeal. I for one do not want Avenue 15 to look like Highway 41 – an auto row with inexpensively housed businesses. The installation of mechanic's shops and gas stations will likely pollute the water table, and definitely add to air pollution with noxious fumes.

Septic tanks are inadequate for this type of development and will eventually lead to all of us in Bonadelle North having to hook up to a drainage and sewer system at great personal expense to the individual household, and at disproportionate benefit to the developer.

Placing businesses at that corner will increase stop and go traffic and therefore increase air and noise pollution and increase the risk of accidents.

Light pollution from the nighttime lighting of businesses is intrusive and incompatible with the rural life of this area, where star gazing is still possible, and moonlit walks are still appreciated.

Wells are the source of our water on this end of the Ranchos. Multiple businesses on land designed for single family

dwelling will put an unnecessary strain on this vital resource.

This area floods on a regular basis and may even require protection under wetlands legislation. The proposed parcels lie in a drainage area for the entire Bonadelle North subdivision. They are composed of vernal pools, which are vital for local wildlife, birds and amphibians, and recharging the water table. In addition, these ponds are an important spawning ground for toads, salamanders and frogs which have been impacted already by development. Without these amphibians, insect pests will greatly increase thus requiring chemical controls that harm good and bad insects, and add to air pollution.

Because of its low-lying topography, the best use of that acreage is as open space or as a low-lying seasonal park area.

The carbon footprint of this proposed development is unnecessary and too damaging to this area of the Ranchos.

I encourage all who believe that this business belongs in the Master Planned business area on Avenue 12, or in an industrial area of Madera, and NOT in the proposed location, to contact the District 1 Planning Commissioner at 645-1132, the Madera County Planning Dept. at 675-7821 and District 1 Supervisor, Frank Bigelow, at 675-7700.

Dear Editor:

This letter addresses the proposal to build a strip mall on the corner of Road 36 and Ave 15. As a home owner who is 125 feet from the corner of Avenue 15 and Road 36 I feel that it would serve no pur-

pose to have a commercial development on this corner. There is not enough of a customer base to support the amount of stores that are proposed for this strip mall. Seems to me that all commercial building should be retained down on Avenue 12.

There has not been an environmental impact report performed for this proposed development. I know for a fact that during heavy rain years that the lot closest to Road 36 will flood with up to 3-feet of water. I have lived in the same house for almost 32 years and believe me, when it rains like it did in 1982 and 1992 any buildings in that spot will flood. If this happens what will the disaster be when the fuel tanks start leaking due to being immersed in rain water? I'll tell you, any property downstream on Cottonwood Creek from Road 36 through Road 34 1/2 and from Avenue 15 over to Avenue 14 will be contaminated with petroleum contaminants as will any farmland adjoining Little Dry Creek and Cottonwood Creek where they join just before the creek gets to the Madera City limits just South of the Highway 99 off ramp to Avenue 12. This encompasses a lot of land and property belonging to dozens of people along the creek's path. This also affects the water table in the area if there is a scenario like the one above – and there will be if weather holds true to form. This will contaminate our drinking water; not only ours who live along the natural waterways but the water source of Madera Ranchos, Bonnadelle Ranchos and eventually Madera city when it spreads.

Last but not least, when I moved from the big city to my present location there was no Madera Ranchos, just one little flat-top house out in the middle of where Madera Ranchos is now, and the big house on the corner of Road 36 and Avenue 12, a few houses on Ave 14 1/2 and a few hous-

es north of Avenue 15, so you can say I moved out of the city to have some peace and quiet and be away from the hustle and bustle of city life. I have loved every minute that I have lived here. My neighbors are wonderful and I see no reason to support this strip mall proposal and do not want it.

So if any of my neighbors see this and concur, please send in your questionnaire and oppose this construction.

Ranchos Library Seeking Grant, Chukchansi Possible Fund Source

There was a murder at the Ranchos Library on June 23 at 2 p.m. All the suspects and detectives were there to investigate, interrogate and examine the evidence. In the end there was only one winner. Fortunately, there was no real victim, but the crime scene, the forensics lab and the evidence looked real, and the teens who participated had a great time solving the crime. 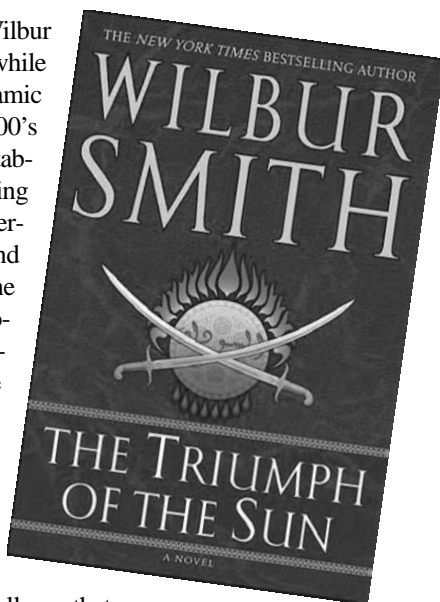

Thanks to all the volunteers who helped sell fireworks at the Chamber/Friends booth.

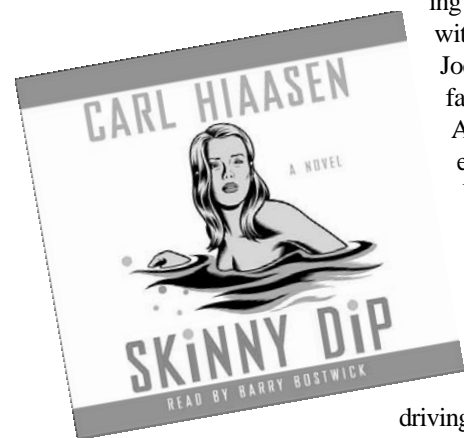
Book Recommendations

Adult Fiction: *Triumph of the Sun* by Wilbur Smith. This action packed adventure is riveting while also giving the reader an understanding of the Islamic culture of the Sudan. It takes place in the late 1800's when the British were in control of Egypt and establishing footholds along the Nile and surrounding countries. The main characters' lives become intertwined in the two cultures and reveal the beauty and ignorance of both. The reader is left to admire the complexities and heroism of both sides. The violence of the battle scenes and the way Islamic justice is meted out at times made me cringe, but the passion of the characters to fight for what they believed in was quite compelling. It's a good book to sink your teeth into on those hot afternoons when you need to escape the heat.



Adult Fiction on CD: *Skinny Dip* by Carl Hiassen and read by Barry Bostwick. Most patrons who listen to books on CD or tape will tell you that

When Chaz Perrone's lovely wife Joey is reported lost at sea presumably from falling overboard from a cruise liner in the Atlantic Gulf Stream, no one suspected her teary eyed husband — not even his girlfriend! Unfortunately Chaz, who earned a doctorate in marine biology, didn't remember which way the Gulf Stream flowed and thought his wife's body would float out to sea. Lucky for Joey, she was picked up by an ex-cop out fishing. Together they team up to get even with Chaz — not by turning him into the police but by driving him crazy and revealing the truth about Chaz's

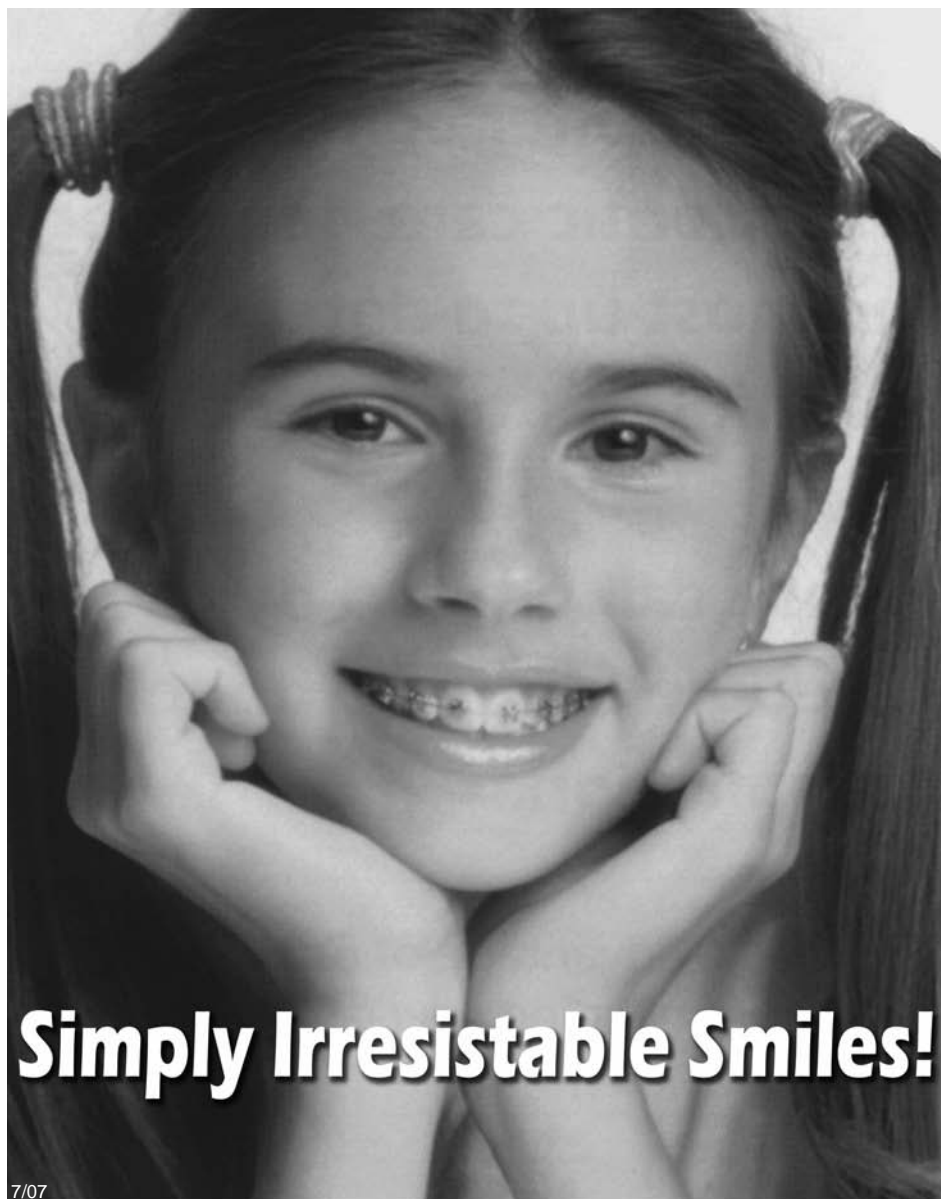


side business with an unscrupulous businessman who is polluting the Florida everglades. It's a rollicking, raucous story that is for adult listening, not for a family ride in the car.

One is a little girl who loses her library book, another a young man who loses earrings meant for a gift to his girlfriend and finally the wife of a chef loses the recipe of his specialty raisin cake. The illustrations are soft and muted and let you imagine the sweltering heat and the bustle of the city. It's a nice summer book for reading to 3-8 year olds.

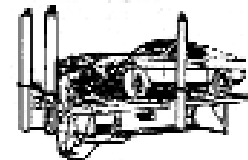

worked with our local newspaper for over 15 years with three different owners. My job with the paper is advertising sales and billing.

Last month on June 23 our dear friends, Jay and Michelle Ford lost everything they owned in a terrible house fire. Jay is also one of our very own firefighters. The family members were all safe at the time of the fire. The cause of the fire is still unknown.

When I got the phone call from my husband, who is also a firefighter, my daughters and I went out to the house to see what we could do to help. When I saw Jay and Michelle standing there I knew I had to do something. This really hit me hard because my husband of 28 years lost everything he and his family owned due to a house fire back in 1978 when we were dating in high school. I remember how hard it was for the whole family and how long it took for the family to get back on their feet. So when this happened to the Ford family I new I had to do something. I made over 100 phone calls and asked people for help, I told them that the Fords needed everything from clothing, food and water to a stuffed animal or two for the Fords' girls as soon as possible. I could not believe my eyes when I saw families backing their trucks and cars in and unloading pickup loads of clothing, toys and other precious items for the Ford family before the fire was even out.

There were families that made homemade lunches and brought ice chests full of water and cold drinks. There was a lady that brought a huge jar with money in it. I also saw children with their parents bring their own toys to give to the Ford girls. There were teenage girls handing me their phone numbers and offering their child care services at no charge. Total strangers offered their own homes.

I also called Randy, the owner of the Ranchos Independent, and asked him to put something in the paper, asking the community for help. I never thought that we would get the

response that we did. As soon as the paper reached the homes, my phone never stopped ringing. I talked to the nicest people that also wanted to help. Within five days of the fire, we received enough stuff to COMPLETELY FILL a three bedroom, two bath rental home in the Ranchos, all donated from friends and families.

There were also families that helped from Merced, Madera, Chowchilla and Fresno . It just goes to show you how many people read our small local Ranchos Independent newspaper ... ALOT!!!

At this time the Ford family would like to say THANK YOU to each and every one of you for helping them get back on their feet. Michelle has decided that with the extra items donated that they are unable to use will be made up into care packages and taken to families in need. THANK YOU AGAIN.

A special note: Since the house fire, our community has been hit hard with another tragedy. The auto accident involving five of our local high school students, taking the life of one. My heart goes out to each and every family involved. Gavin Knobloch, who was seriously injured in the accident, is my neighbor. His family lives across the street. The other children involved I did not know personally, but I had seen them or a family member at one time or another around the community. We need to say a special prayer for them and help the families in any way we can, as it is going to be a long healing process now for all involved.

The Stock Report**Tragedy Touches LHS, Ranchos**

Hi Neighbors,

This has been a sad week in the Ranchos community. It all started on Sunday, July 8 very early in the morning with a car accident involving five Liberty High students. The three boys involved are Liberty High football players. Donovan Tessmer was killed in the accident. He would have been a senior at Liberty. The community has rallied around Donovan's family to help them through this very trying time. There has been a scholarship in Donovan's name started. You can contribute by sending your donation to the Foundation for Golden Valley Schools at 37479 Ave. 12 Madera, Calif. 93636. Be sure to say " in memory of Donovan Tessmer." His family, friends and the community will miss Donovan.

A memorial service for Donovan was held Monday, July 9. Fellow classmates put the service together to honor Donovan's life. Pastor Carl Roth did an outstanding job in pulling all of the pieces together in such a short time. Eight girls put together a beautiful slide show with music. I don't know how they put it all together so quickly. Some other girls put together five memory books that people could write in for Donovan's family and the other students who were in the car at the time of the accident. Alex, who was in the car, spoke at the

memorial service and so did Donovan's sister Megan. The memorial service started in the Liberty High gym then moved outside for a candlelight vigil, where Martha, Donovan's mother, spoke to the crowd. The procession led into the Liberty Cafeteria where refreshments were served. Donovan's funeral was held Friday, July 13 at 10 a.m. at the Northside Church in Fresno.

Two of the students who were in the car are still in the hospital in serious condition. One boy and one girl escaped serious injury. My heart goes out to all five families as they deal with the aftermath of this terrible tragedy. Accidents happen in a split second but the consequences live on for a lifetime.

Now I have to change subjects and talk about what is happening in the school district. On a lighter note have you been by Webster Elementary School lately? It is a beehive of activity over there. I pass by every morning so I can watch the progress. At first it was all the tearing up of old roofs and old parking lot black top and cement. If you live out here you know that our mud has no bottom until you reach hardpan. After the heavy equipment was

The fliers were printed on both sides with a stamp on one side and were to be returned to Superstition Builders, Inc. with an opinion about the project. The owners suggest 44,530 square feet of buildings. Their design shows:

Office Space Coffee Shop Farmers Market Oil Change Automotive Repair Restaurant

pulled out the contractor realized that all of the wet dirt in this hole had to be dug out and the hole filled up with dry dirt before they could continue working on the parking lot. All is well now and the new parking lot looks beautiful.

Two months is not a long time to tear up and completely remodel a school but things happen fast in this school district. I learned that everything was on time and some things even ahead of schedule. Last Friday I saw that the first of two new portables had already been set in place and that the last one would be in place this week. There is still a rush to get the work done so that the teachers can have the time they need to get their materials out of the storage containers where everything was put at the end of the school year. I don't envy the teachers the job of putting their rooms back together. It is hard enough getting your room ready at the beginning of the school year, let alone having to

unpack boxes to find your materials and then find a place for everything. By the way school starts on Thursday, August 16. Webster has planned their open house for August 16 if everything goes according to plan. You might want to come see what has been done to remodel Webster.

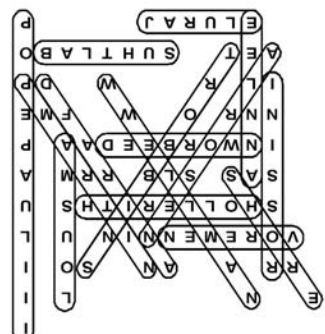

Dear Editor:

I am writing in response to the email you received from Officer Jeff Williams about his son Kyle's death. In February 1981, I came home one evening to find my

14 year old son unconscious. I called for an ambulance because I was just sure the paramedics could find out what was wrong and give him something to wake him up. He died from inhaling nitrous oxide.

When a child dies, it is the most unbelievable thing in the world. It just seems so cruel, unnatural and unbelievable. Having it sink in and become believable rocks you to your very soul. He just couldn't be gone – it wasn't supposed to be that way. You do NOT outlive your children!

After his death, like Officer Williams, I started looking for answers, information and anything I could find out about this idiocy. I found out that nitrous oxide could also be found in whipped cream cans and probably many other products needing propellants. The kids seem to be the only ones with this knowledge and, like Kyle and my son, Jim, one thing they don't know is that in addition to not knowing their level of tolerance, is that if they get even a little bit of the whipped cream into their lungs, they will not survive according to a physician I spoke to from the Department of Health. There is a lot of shortening in whipped cream and it coats the inside of their lungs. There isn't any way to get it out so it suffocates them.

I think the parents are the ones who need information. The kids evidently know that they can buy whipped cream, Dust Off and all the other cans with propellants without an ID, and without adults knowing about it for the most part. After Jim's death I mentioned to a manager in a grocery store that the two boys about 11 years old that had just bought whipped cream were not buying it for their mothers. They were, in all likelihood, buying it for inhaling. The manager told me that they couldn't do anything, as it wasn't illegal, but that this was something they were seeing several times a week – 26 years ago!

Many have said "all kids will try drugs once." There are all sorts of "drugs" out

there that are available to anyone, like the whipped cream and Dust Off, as well as street drugs, but when they are used, no one knows who will have an allergic reaction to some filler used, who will have an overdose on a small amount because of their individual makeup, or who might be on a cold medicine or a prescription that could react badly to any other "drug."

How can parents protect their children when they don't even know what "drugs" are available and that many of the "unknown to parents drugs" are at their local stores? There has to be an answer out there – and it has to be widely known by parents very soon.


ing fathers envisioned?

One may think that an outrageously loud motorcycle, car stereo or a monstrous dust cloud is just another form of civil liberty, but when that civil liberty is arrived at through illegal means and interferes with another's rights it is foolish to attempt to defend it as anything else but a violation of the law. Simply stated, the real shame here is that the very laws that Mr. Cake claims to be victimized by were created to protect the majority of others from the thoughtless and inconsiderate actions of a minority of people.

Legal aspects aside, what of the moral aspects, wherein the real solution to these problems lie? According to Mr. Cake's letter to the editor some months ago, he was upset that a neighbor called the Sheriff to complain of the noise and dust created by his weekend off-road motorcycle riding activities. Instead of complaining about how unfair it is that another person called the Sheriff for relief from his actions, maybe Mr. Cake should spend a minute considering how his actions could be affecting those around him. This concept is called consideration of others, and it seems to be in short supply these days.

So who's really the bully here? Those

She managed to furnish a three bedroom home with furniture, food, clothing, toys and personal items in FOUR days! The donations started to come in even before the fire was out. They opened up their home to our family for a week and disrupted their lives to help us out in our time of need. I don't know how we will ever repay them, but Jay and I will try, as long as we live.

Please accept this thank you for your generosity and comfort for our family in our time of need. Also, know that if any of you need help, we will try our hardest to be there for you or your family. The Story Behind the Handcrafted, USA-made Vintage Aprons

After the test results came back, the allergist told Lucy Tangrady something she didn't want to hear.

"Move out of the Central Valley or your asthma will continue to get worse. Within a year you'll carry an oxygen tank, and sooner than later, you'll die."

The words were a harsh reality for someone who had called Merced and Fresno home for more than 30 years. She'd leave behind her long time job

with UBS, the church she was married in and attended regularly, her family and friends. The trips to Yosemite, the coast and the Bay Area would soon be a distant memory.

"Oh, and don't forget In 'N Out," Lucy says with a smile as she

looks up from sewing a pocket onto her latest apron. "Not to mention the fries and the chocolate shakes."

Everything would be in the rear view mirror except her husband Jim and their Golden Retriever Zoey.

"I did have one very driving force behind me that made it bearable," Lucy said as she straightened one of her patterns. "My faith in the Lord. I know He won't forsake me, I know He has a plan and sometimes I have to be reminded to just get out of the way."

In April of 2006, Lucy, Jim and Zoey moved their life to Meridian, Idaho, about 5 miles from Boise.

One of the rooms in the new house was designated as "Lucy's Sewing Room." It faced the street and had big windows that let the bright Idaho sunshine in. While she was raising three daughters Lucy learned early on it was cheaper to make clothes than to buy them. And, inspired by her Mom who sewed frequently, Lucy learned to love sewing. Knowing how adept Lucy was at sewing, in the fall of 2006 one of her sisters asked Lucy to make her an apron for Christmas. "I just kind of winged it. I

had fun doing it, and when it was done, a few people saw it and wanted one of their own."

She pauses to take a sip of water and cut away a loose thread.

"I'm a nice person but I told them if I was going to make an apron they had to pay for my time." She spots yet another errant thread. "No one protested. In fact, I got more orders for more aprons. I guess that's how 'ITZSEWLUCY' was born."



Every ItzSewLucy Vintage Apron begins the same way with the selection and cutting of fabric. Throught their website, www.itzsewlucy.com, you can choose from hundreds of styles and patterns.

What started as a hobby in a bedroom has blossomed into a full-fledged business and that bedroom is overflowing with fabric bolts. "We have over 180 fabric choices now and every day there's more. It's starting to look like I

opened my own Jo-Ann's or Hancock fabric store."

"There are four stores carrying my aprons and I'd have more, but I just can't sew them quickly enough." Recently we started selling designer name fabrics on the site. In some cases, we're \$2 - \$3 per yard less than the upscale fabric stores."

Besides the stores in Boise, Kuna, Emmet and McCall, Idaho, Lucy and Jim sell the aprons at a Farmer's Market-type venue in the adjacent town of Eagle.

If the apron business wasn't time consuming enough, Lucy also works full time as a Branch Office Administrator in Meridian.

"It's daunting at times," Lucy says as she places her latest apron on her dress form to take a picture so it can be displayed on the "ITZSEWLUCY.COM website."

"Sometimes I just have to work at catching my breath," she flashes a wry smile. "But living here, it's much easier to do that." She begins cutting yet another apron pattern. "We really miss our friends. But with the phone and email we are able to stay in touch. I just wish In 'N Out was closer than Reno."

Next comes the hard part - putting the pieces together and stitching them up to create unique, truly hand-crafted reversible aprons that look like mini works of art.

state and federal agencies to routinely (and unilaterally) create, update and modify lists of species of flora and fauna that could be threatened or endangered. Now, don't get me wrong; some of these listings have been useful and constructive in preserving and/or restoring species to health and viability. The bald eagle is one example of a species that has been restored. However, there are literally HUNDREDS of plant and animal species that are "protected" by this law, and most of these species (like the acronyms) you've never even heard of, BUT woe be to you if you have a piece of property on which one of these plants or animals happens to make a home.

Now, you may ask, "...but how does this affect me?" Or you may say "...but I like bald eagles." Point well taken. I like bald eagles, too and I'm glad we took the steps to protect and restore them. But, let me ask you this: do you feel the same way about Vernal Pool Fairy Shrimp (VPFS)? Are you enamored by the Arroyo Toad (AT)? Do you have a love affair with the California Tiger Salamander (CTS)? These are just a few of the hundreds of species that are currently listed as "protected" in the state of California, and could very possibly have a very large effect on you and on your neighbors.

Let me try to point out just how these "listings" have affected things. In southern California, the last link of a badly needed freeway project was in the last stages of approval prior to construction when a very peculiar thing happened. This roadway was to run parallel to Interstate 5 starting just below San Clemente and linking up with Highway 91 in the City of Anaheim. This last link of roadway would have taken literally thousands of cars off I-5 and greatly improved traffic circulation in the entire region. HOWEVER, at the eleventh hour, the Arroyo Toad made the list of "endangered" species. Now, where, you might ask, does the Arroyo Toad make its home? You may have already guessed the answer. The "Primary Habitat" for the Arroyo Toad in the state of California just happens to be along the few mile stretch of right-of-way that was to provide for the construction of the badly needed road.

Now, you might say "...thank God we caught it in time. If we were to allow that road to be built, what would ever happen to the precious Arroyo Toad?" I, however, have become a bit more skeptical in matters environmental. I recognize that the radical environmental community had once again interfered and delayed the construction of a needed piece of infrastructure. A roadway that was to be constructed FOR THE BENEFIT OF THE PUBLIC. If the Arroyo Toad needed protection, why wasn't it provided for in a timely fashion, so that the roadway planners had sufficient time to make the necessary adjustments to their plan in advance? To me, it's just another example of placing the needs of toads ahead of the needs of the people. To date, after many years, the badly needed piece of roadway is still tied up in an environmental spider web.

"Well," you might say, "those crazy people in southern California deserve everything they get." Not so fast. Do you know where the Primary Habitat in the state of California for Vernal Pool Fairy Shrimp and California Tiger Salamanders is located? GULP! Right here in lovely Madera County. More particularly, southeast Madera County, including most of Rio Mesa! I have it on good word from a very reliable source in Madera that the state and federal environmental agencies have brought forth a very recent map that identifies very large tracts of land in Rio

Mesa as Primary Habitat for the California Tiger Salamander. If all of the area on the proposed map is set aside as "protected habitat," then the properties affected could be rendered "unbuildable."

This could prove to be rather inconvenient, not to mention extremely costly. Rio Mesa happens to be the primary "New Growth Area" in Madera County. The county was hoping to get a number of projects started in Rio Mesa over the next couple of years. Among the projects that could be impacted in Rio Mesa are Larry Freels' "River Ranch;" Bob McCaffrey's "Peck Ranch;" John Kesterson's "Northfork Village" project; and the Coombs Ave 12 Village project. These projects represent literally thousands of future housing units that were to serve the growth needs of the county over the next decade.

Now, I'm not saying that there won't be any units built. What I am saying, though, is that there will probably be a lot fewer units built, that it will take a lot longer to build them and that they will be a lot more expensive to buy. In the case of John Kesterson's project, the impact could be devastating. The set-aside for Salamander Habitat could render Kesterson's project "unbuildable." I suppose that Kesterson could go out and buy a bunch of land to give to the environmentalists to protect the Salamanders. I can just hear the cash register ringing as the cost of housing in Madera goes up again. I feel sorry for John Kesterson. He has waited patiently over the years to build his project. He was next in line to go to the Board of Supervisors for approval after the Gateway Village project. No telling how long he may have to wait now.

You may not feel sorry for Kesterson. Let me put it in another perspective. You should feel fortunate that you have your home in either the Ranchos or Rolling Hills. If the Fairy Shrimp and the Tiger Salamander had been around at the time, NEITHER ONE OF THESE COMMUNITIES WOULD HAVE BEEN DEVELOPED!

So, I guess we need to ask the question "Will they ever begin?" I guess we'll have to wait and see if the answer is yes or no. I suppose Rio Mesa will eventually get started. The more important question is "Will it ever end?" I think that the answer to this one is evident. As long as the bright young bureaucrats and the lawyers who work for the acronyms have the power they do, it will never end. What ever happened to our beloved "Golden State" any way? How did we allow it to get hijacked from under our very noses?

This is just hot off the press: The Governor recently fired the head of the state Air Resources Board because that head had the audacity to postpone the implementation of stringent air quality measures for the Central Valley. Now don't get me wrong. We need to provide solutions to the problem of air quality in our region of the state, however the rushed implementation of Draconian measures that are both costly and anti-business are not the answer. So who did the Governor appoint to replace the ousted head of the Air Resources Board? None other than Mary Nichols.

Now, who is Mary Nichols? Mary Nichols was the former secretary of the state Resources Agency under Governor Grey Davis. This is the most powerful environmental job in the State of California. Mary Nichols is an attorney with the Natural Resources Defense Council. Yes, the same NRDC that you read about near the top of this article. The same NRDC that has Robert F. Kennedy, Jr. and the rest of those east coast, Learjet liberals as members. Kinda' makes you wonder who's running the show ...

Teens and Automobile Accidents: Unnecessary and Very Preventable

All of us, especially we who love to spend time teaching our teenagers, were once again recently stunned and saddened by the news of yet another tragic teen-operated vehicle fatality. Another UNNECESSARY and preventable fatality. I would like to dedicate this month's article to all of the family members and close friends hardest hit by this tragedy and loss and to all of the new and soon to be new teen drivers and to all of the parents of these teens in an effort to bring better focus to the problems encountered by teen drivers and to examine some of the things we can all do to help eliminate another unnecessary teen death. After all, these young people are our future, not to mention our children, brothers, sisters, best friends, school and teammates. They are each so precious beyond description.

First, as much as we would rather not, we all need to read the following stats with our teens. We need to be very involved. We need to communicate often with our teens. We need to know their plans daily. We need to know ALL of their friends. We need to establish a strict list of vehicle use rules but most importantly, we MUST make sure they are adhered to. WE CAN MAKE A DIFFERENCE. WE CAN PREVENT THIS FROM HAPPENING AGAIN.

Let me begin by repeating what one expert reported:

THE NUMBER OF TEENS KILLED IN VEHICLE-RELATED ACCIDENTS IS EQUAL TO A LARGE COMMERCIAL AIRLINER FULL OF PASSENGERS CRASHING EVERY WEEK.

Teen Driving Stats

Driving with your friends? Statistics say that teens ages 16-19 are four times more likely to experience an automobile accident than older drivers, and of over half of these accidents there are more than one teen in the car. Because of this, teens are disproportionately involved in crashes as drivers and as passengers.

Fact 1

14% of all deaths due to driving accidents are a teen driver.

Fact 2

53% of automobile deaths involving teenagers occur on the weekends.

Fact 3

45% of the time, teen drivers killed in automobile accidents also had a fellow teen or youth in the vehicle.

Fact 4

Of all teens that were fatally injured in a driving accident, 1/3 of those accidents were speed related. Don't speed!

Fact 5

Teen drivers' lifestyle of staying up late causes teen drivers to have a higher risk of automobile accident due to drowsiness.

Fact 6

On the basis of current population trends, there will be 23% more 16-20-year-old drivers on the road in 2010 than there are today - 26.1 million.

Fact 7

This age group makes up 7% of licensed drivers, but suffers 14% of fatalities and 20% of all reported accidents.

Fact 8

Crash rate per mile driven is twice as high for 16 year olds as it is for 18-19 years.

Fact 9

Teenage males are statistically at a higher risk for accidents than teenage females. Two out of every three teenage driver accidents involves a male driver.

Fact 10

Car crashes are the #1 cause of deaths for 16 year olds. Automobile crashes are the leading cause of teen deaths in the United States.

Fact 11

At 35 mph, a 2 second lapse in attention means you've traveled 100 feet without looking!

Fact 12

Teens have the lowest seat belt use rate of all drivers. This rate becomes worse when there are other teens in the car.

Fact 13

During the first year of licensed driving, 1-in-5 male and about 1-in-10 female 16-year old drivers will have a crash.

Recent Stats

In 2004, 5,610 teenagers died in the United States from motor vehicle crash injuries, making driving the leading public health problem among people 13 to 19 years old. The risk is particularly high during the first years in which teenagers are eligible for driver's licenses. In 2002, the latest year for which data are available, 41 percent of all deaths among 16-19 year-olds from all causes were related to motor vehicles.

Fact 1

16 year-olds have higher crash rates than drivers of any other age.

Fact 2

It is estimated that 16-year-olds are three times more likely to die in a motor vehicle crash than the average of all drivers.

Fact 3

3,657 drivers age 15-20 died in car crashes in 2003, making up 14% of all drivers involved in fatal crashes, and 18% of all drivers involved in police-reported crashes (NHTSA).

Fact 4

Crash risk is particularly high during the first years that teenagers are eligible to drive. The top five driver-related factors for teenage drivers involved in fatal motor vehicle crashes include:

- Driving too fast
- Running off the road
- Driving in the wrong lane
- Driving under the influence of alcohol, drugs, or medication
- Erratic or reckless driving

Fact 5

In 2001, two thirds of teens killed in auto accidents were not wearing seat belts. Belt use among fatally injured passengers ages 16-19 was considerably lower than among teenage drivers. Compared with other age groups, teens have the lowest rate of seat belt use.

Fact 6

Almost half of the crash deaths involving 16-year-old drivers in 2003 occurred when the beginning drivers were driving with teen passengers (IIHS). Statistics show that 16 and 17-year-old driver death rates increase with each additional passenger (IIHS).

Fact 7

Young drivers are less likely than adults to drive after drinking alcohol, but their crash risk is substantially higher when they do. This is especially true at low and moderate blood alcohol concentrations. The estimated percentage of fatally injured passenger vehicle drivers ages 16-17 who had BACs at or above 0.08 percent in 2004 was 15%, down 63% since 1982.

Fact 8

Most of this decline took place in the 1980s. This age group experienced the greatest decline in alcohol involvement, compared with a 47% decline for drivers ages 18-20, a 23% decline for drivers ages

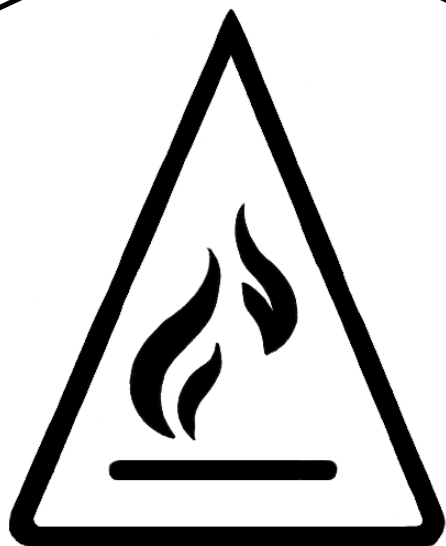

21-30, and a 35% for drivers older than 30.

Fact 9

Graduated driver's license programs appear to be making a difference. The Insurance Institute for Highway Safety reports that the overall number of 16-year-old drivers fell from 1,084 in 1993 to 938 in 2003 despite an 18% increase in the 16-year-old population.

Fact 10

About two out of every three teenagers killed in motor vehicle crashes in 2004 were males. Since 1975 teenage motor vehicle crash deaths have decreased more among males (44 percent) than among females (13 percent).

Fact 11

Eighty-six percent of teenage motor vehicle crash deaths in 2004 were passenger vehicle occupants. The others were pedestrians (5 percent), motorcyclists (4 percent), bicyclists (2 percent), riders of all-terrain vehicles (2 percent), and people in other kinds of vehicles (2 percent).

Fact 12

The rate of nighttime fatal passenger vehicle crashes per 100 million miles traveled in 2001-02 was almost six times higher for male drivers ages 16-19 than for male drivers ages 30-59. The corresponding comparison for females yields three times the rate.

Fact 13

Fact 14

Fact 15

The risk of a crash involving a teenage driver increases with each additional teen passenger in the vehicle.

Fact 16

Fifty-four percent of motor vehicle crash deaths among teenagers in 2004 occurred on Friday, Saturday or Sunday.

be importing, from outside the area, a surface water supply that is sufficient to serve 100% of the needs of the entire project at build-out, and enough additional water to balance the over-drafted underground aquifer. This will help stabilize the long term water supply for both the neighboring agriculture and the Rolling Hills and Ranchos communities.

Furthermore, after months of negotiations with Golden Valley Unified School District, Gateway Village has agreed with the School District on a set of business points for the provision of new schools for the project. The formal agreement is currently being drafted and it is anticipated that Castle & Cooke will have the agreement signed before the meeting with the Board of Supervisors. The

Gateway will pay 100% of the actual costs for new project schools. Per the terms of the agreement, the existing community and the School District will have no risk whatsoever for Gateway project schools.

agreement calls for Gateway Village to provide all of the school facilities necessary to serve all of the students that will reside in the project. No Warnings: Illegal OHV Use Over

Anderson has announced that, “Deputies who spot anyone riding an off road vehicle either on their property or on roads in residential areas not only face citation but their vehicle will be impounded.”
