












Body of Man Found in Orchard South of Ranchos

If Ruled a Homicide, Will be Fourth in 2011 for Madera County

The Madera County Sheriff's Department is investigating the death of an older African American male found on the morning of Dec. 21 in an olive orchard on the southwest corner of the intersection of Avenue 7 and Road 34. The body was discovered about two rows into the olive orchard off of the road. The naked body was discovered by a worker shortly before 9 a.m.

An autopsy was performed but failed to render a cause of death and Sheriff John Anderson is calling the death "suspicious." The Sheriff's Department is now waiting for the results of toxicology tests, which won't be made available for two to three weeks.

The victim remains a "John Doe" at this hour but is described as a light skinned, elderly African American. He stood 5 feet 8 inches tall and weighed 160 pounds. He was completely bald and sported a salt-and-pepper-colored mustache and goatee. He also had a 9 inch scar across his torso. One outstanding characteristic was that he had a "cauliflower ear" on the left side, possibly indicating that he was a boxer at one time.

One of Four, if Ruled Homicide

If this is ruled a homicide, it will be the fourth this year. In chronological order of 2011 coroner cases:

- cide 23-year-old Crystal Lynn Lewis (DOB 9-15-1987) killed her 5-year-old daughter in the home where they lived, located on Windsong Way just north of Ahwahnee, roughly a half mile south of the Madera/Mariposa county line. Crystal's body was discovered under the William Sells Jr. Bridge at approximately 7:30 a.m. in Mariposa County about 2 and a half miles from Crystal's home. It is believed Crystal jumped to her death.
- 2. February 17, 2011 Bass Lake Double Murder/Suicide the suspect, who died from a self-inflicted gunshot wound, was identified as 71-year-old James H. (Jim) Williamson (DOB 2-27-1939). The victims are identified as San-

He lived here, grew up here and his family still resides on Road 37 that was dedicated in his honor. His life cut short by an IED in Iraq, he will not be forgotten in the Ranchos.

Re-striping of Avenue 12/June • Nothing has the potential of throwing a small community into an uproar like messing with something that everyone takes for granted on a day-to-day basis, like its main road. But the County of Madera came out, restriped Avenue 12 to provide a dedicated center turn lane and got rid of cars (and trucks) parking on the sides of the road and the community accepted it flawlessly.

Massive Stash Found in Ranchos/February • An

unassuming home on Avenue 12 piqued the curiosity of a Sheriff's Deputy who noticed some burning in the back yard. By the time all the ashes had settled, hundreds of thousand of dollars in stolen property from all over the Central Valley was discovered, along with drugs, money and criminals. Wow.

Madera County's Top Drug-Sniffing Dog to Retire

Sergeant Tyson Pogue and Zak.

A pint-sized Springer Spaniel, who for nearly 10 years has demonstrated almost daily why he is Madera County law enforcement's greatest pride and joy, retires at the end of this month. K9 Zak earned a reputation as a top dog among drug sniffing canines by local, state and even federal officials.


Bred in England, this highly trained Springer Spaniel came to the

United States in 2003 and on the 4th of July of that same year was paired with the only partner he's ever known, Sergeant Tyson Pogue.

His achievements are many and to give you an idea of just how exceptional Zak is, here are some K9 stats, chalked full of successful alerts and seizures during the course of his nearly decade long service:

- Zak was deployed more than 600 times to search for narcotics resulting in more than 200 felony arrests.
- Zak has alerted officers to more than 350 areas found to contain narcotics resulting in the seizure of more than 4,300 grams of methamphetamine, 21,000 grams of marijuana, 1,515 grams of cocaine, 158 grams of heroin, several vehicles and \$785,000 in cash. The street value of the narcotics seized is around \$350,000.
- Zak located the odor of narcotics more than 4,000 times during our more than 1,500 hours of training and countless public K9 demonstrations.
- Zak and his handler, (partner and friend) also served on Madera County's Drug Task Force known as MADNET.
- Zak has not only been an asset to the Madera County Sheriff's Department, but he has been deployed to assist countless agencies including the Fresno Police Department Major Narcotics Unit, the Mariposa County Sheriff's Dept., United States Forestry Law Enforcement Division, California Department of Corrections, California State Pa-

role, California Department of Fish and Game, Madera County Probation, Madera County Narcotic Enforcement Team, Madera County Department of Corrections, Madera Police Department, Chowchilla Police Department, Los Angeles County Sheriff's Department, Madera Unified School District, Yosemite Unified School District, California Department of Justice Bureau of Narcotic Enforcement, United States



Back in 2003, barley two months into his job, Zak was already making headlines. With almost 50 arrests already under his collar, Zak started making his presence known especially during one particular traffic stop in Oakhurst. K9 Zak was deployed during the stop and quickly alerted his handler to a backpack just behind the passenger seat. Inside, Deputies found a bag filled with a usable amount of methamphetamine. A glass pipe would be found in the driver's pocket and a vial filled with meth in the passenger's pant pocket.

Later, Zak was back in the news again, this time, for helping the Madera Police Department close a complicated drug case. It all started when Madera Police Officers seized nearly \$100,000 from a vehicle in the city of Madera. While the Police Department has K9's, they don't have dogs trained to sniff out narcotics, so the Madera Police Depart-

The Madera County Sheriff's Department made a list for shoppers to check so they can find out for themselves if they are doing all they can to avoid falling prey. Sheriff John Anderson is also issuing his annual list of basic tips highlighting simple steps citizens should take to stay safe all year long.

Protecting your vehicles and

valuables stored inside:

Don't leave your car unlocked even if you know you will be gone for just a few minutes.

Don't leave purchased items in plain view inside your car. Instead, store them in the trunk of your vehicle where they can't be seen.

Don't leave your vehicle unlocked when gassing up. You'll have better peace of mind knowing your car is secure when filling your tank and paying at the pump.

Don't leave your car unlocked while driving. Thieves can easily open a door while you wait at a stoplight. Keep your doors locked at all times.

Protecting you and your valuables while shopping:

Don't place your purse in your shopping cart when shopping for gifts or groceries. Turn your back for just a second, and your bag may be gone.

Don't leave your purse in your cart when placing items in your car.

Don't place your personal effects on the hook of a restroom stall or on the floor where thieves can reach them. Instead, keep them close to you at all times



A very sick Bill Bell knew that his time on earth wasn't much longer and he desperately wanted someone to keep the Ranchos Independent alive. At that time, local papers were being bought up by larger regional papers and he didn't want to see that happen. As a matter of fact, he didn't want to see the Ranchos Independent be bought by someone outside of the Ranchos because he felt that such a person just "wouldn't get it" about what the Ranchos is all about. People outside of the area courted Bill but he held firm until yours truly came along.

I've told the story before, but the way I first made contact with the Ranchos Independent was a letter to the editor I had sent in favoring Sierra View Elementary school joining in with the newly formed Golden Valley Unified. I had included my name, address and phone number on the letter (like you're SUPPOSED to ... a concept seven years later that I can't get certain pockets of my readership to grasp) and Bill inadvertently published ALL of that information in the paper. I was pretty hot when I went into the Ranchos Independent office that first time but was laughing it all off by the time I left.

Not too long after that I was calling on another advertiser for a magazine that

I used to publish and the advertiser told me that the Ranchos Independent was for sale. I started talking to Bill Bell and after a few visits he was convinced that I would be a good fit for the Ranchos Independent.

I'm still here.

In the seven years that I've had the paper I've seen a lot of things happen in the Ranchos. Most recently I've witnessed the shrinking number of businesses in the Ranchos. I've seen the impact that has had on the Golden Valley Chamber of Commerce, a venerable institution that has been helping area businesses for the last 20 years, but now finds itself struggling. I get people asking me how things are going down at the newspaper and I tell them, "Great ... if I could keep the number of advertisers up." Today, those advertisers aren't just being coy or frugal with their advertising dollars; they don't exist anymore.



Are you or someone in your family a diabetic? Or have you been told by your doctor that you are borderline diabetic? You feel like it is the end of the world. For those of you that have just been diagnosed, I know exactly how you feel. Preheat oven to 425. Remove one crust from pouch. Place on a cutting board or flat surface and roll out lightly to a 10-inch diameter. Using a 4-inch round cutter, cut out six rounds. Set scraps aside and



repeat with second crust.

Lightly press the pastry rounds into 12 muffin cups pressing into bottom and up sides to create pastry cups. Prick sups with a fork and bake for 5 minutes.

In a medium bowl, mix together the cherry pie filling and the sweetener. Gently fold in the raspberries. Spoon about 3 tablespoons of the filling into each crust lined



Based on the evolving nature of these matters, it is probably prudent for us to limit what we say until we know more and can be sure that we are providing useful and accurate information. Yet we wanted to be responsive to your numerous inquiries in the timely, transparent, and respectful manner that reflects how we have always done business. Accordingly, below is the official statement we released today. There will certainly be more information in the near future.

Interim North Fork Rancheria Statement On Events of 12/6/11

The North Fork Rancheria has offered its full cooperation in the investigation being conducted by the Office of the Inspector General for the U.S. Department of the Interior. The

investigation apparently concerns the use and disclosure of the limited funds advanced to the Tribe for its proposed casino project under its development agreement with Station Casinos.

This information is routinely made available to tribal citizens in considerable detail, including general ledger records of each and every check drawn from the project and other unrestricted tribal funds. The Tribe therefore does not understand the basis for the investigation, and is dismayed that information that the Tribe would have been more than willing to provide is instead being secured with a search warrant.

A New Holiday Tradition ... Not!



Give yourself the best Christmas ever; really know what it is truly all about. Learn John 14:6; commit it to your heart, mind, body, soul and life!



What's on Your Plate?

As we approach the New Year, a good question to ask yourself is: "What's on my plate?" Don't worry; I'm not talking about dieting and counting calories. Although, come to think of it there are some really good comparisons between filling our food plates and filling our schedules.

When you overfill your plate you're likely to end up feeling lethargic, unproductive, and maybe even a little sick. (Does that bring back any holiday dinner memories?) Over-filling your schedule can do the same

thing. We get drained by a surplus of activity; worn out by a non-stop schedule. We push and push until our bodies say, "Enough!" Our immune systems are compromised and we end up sick.

So how do we alter this lifestyle? Begin with identifying your life values. List the four or five things that are your top priorities in life. Those become the plumb-line from which to gauge what stays, what goes, and perhaps what needs to be added to your schedule.

Rather than being a victim of the wishes

and demands of others on your time, be intentional about what you choose to do and not do. Based on the priorities you've identified, outline specific goals that will give you focus and direction. Follow up goal-setting with specific steps of action that will enable you to see your values lived out in your daily lifestyle.

For instance, say building a strong family is one of your values. A goal might be to spend more time together. A step of action might be to have dinner together "X" number of times per week.

Once you've established your plan, give yourself permission to set boundaries for things that would interfere with that plan. If your committee is having a late afternoon meeting, let them know you have a commitment and need to leave by 5:30.

Another goal for your family value might be to have your home a place of comfort and refuge for family members. A step of action might be to clear the clutter and make it a place the family enjoys coming home to. You might be thinking, "I just don't have time to get it that way and keep it that way!" In their book *Organizing for the Creative Person*, Dorothy Lehmkuhl and Delores Cotter Lamping say, "'I don't have time' is an excuse; 'That isn't the best use of my time now' represents a conscious decision. When you say, 'I don't have time to clean my desk every day,' think about this: If someone were to give you \$1,000 every single day you cleared off your desk, would you find time to do it? We all would!"

The goal here is to make conscious choices about how we use our time and for those choices to enhance rather than inhibit what we value most. This will take some time for planning and determination to follow through, but the results will be a life worth living.

A Brief History of Christmas, Courtesy of the Ranchos/Hills Senior Center

Christmas has been celebrated on December 25 since 336 A.D. The tradition started as a Christian holiday honoring the birth of Jesus and has evolved into an international holiday that embodies family togetherness and good cheer.

While some still regard Christmas solely as a religious holiday, Christmas has become, for many, a day to celebrate family and be merry. In the spirit of holiday cheer, many observe the traditions of Santa Claus, mistletoe, Christmas trees and Christmas cards described below.

The tradition of Christmas trees was started in 16th century Germany. Martin Luther, a German theologian, is thought to have popularized the concept. On a brisk, clear Christmas Eve, Luther was walking home under a bright, starry sky, which was so beautiful that he wanted to recreate its beauty for his children. His idea was to decorate a large evergreen with glowing candles, a custom we still honor today in more modern forms.

And last, but not least, the Christmas card, probably the most popular way to express holiday sentiments, was started in England in 1843. The first Christmas card was printed in

the United States in 1875 by Louis Prang, a Massachusetts printer. By running nationwide contests for the best Christmas designs, Prang helped launch Christmas cards into a multibillion dollar industry.

serving dishes. Chill for at least 30 minutes before serving. Each serving is 97 calories, 16.2 g. carbs, and 6.1 g. sugars.

Knowing how much I like any dessert made with lemon, this one is for lemon bars.

Old Fashioned Lemon Bars Crust:

1/3 C Splenda granulated Sweetener

½ C whole wheat flour

½ C white all-purpose flour

1/4 tsp. baking powder

4 T margarine, hard or cold butter

2 T buttermilk

½ tsp. salt

Topping:

2 tsp. powdered sugar, optional

2 large eggs

1 egg white

3 T white all-purpose flour

baking, or ½ C EACH Splenda granular and granulated sugar

2/3 C fresh lemon juice 1/3 C low fat buttermilk 1 T fresh grated lemon peel **DIRECTIONS:**

CRUST: Preheat oven to 375 degrees. Spray an 8-inch square baking pan with nonstick baking spray. In a medium bowl, mix together flours, Splenda, salt and baking powder. Cut in margarine (or butter) until mixture resembles coarse crumbs. Sprinkle buttermilk over mix and blend. Press onto the bottom of the prepared pan. Chill for 15 minutes and then bake for 15-20 minutes or until lightly browned.

TOPPING: While crust is baking, prepare topping. In a large bowl, beat eggs and egg white with 3 T flour and ½ C of Splenda or Splenda/sugar blend. Beat in 1/3 C buttermilk, lemon juice and zest. Pour into hot crust. Turn oven down to 350 and bake bars an additional 18-20 minutes or until top is set. Cool completely. Just prior to serving, dust with powdered sugar if desired. Cut into 16 bars. 107 calories, 15 g. carbs and 3.8 g. sugar for each bar.

There you have it – three recipes ½ C Splenda sugar blend for that should let you have dessert and not destroy your sugar count. I sincerely hope you are able to keep your glucose under control because we all know what can happen to you if it gets out of control.





Madera Man Hammers Wife's Head **Receives Lengthy Prison Sentence**

Victim's Daughter, 12, Saves Mom's Life

On Monday, Dec. 19, Bruce Armstrong was sentenced to a lengthy term in state prison according to Michael R. Keitz, District Attorney for Madera County.

Armstrong, 34, of Madera, was convicted by a Madera County superior court jury earlier this year on April 14 for two separate actions which occurred in 2008. During his first assault, Armstrong entered his wife's workplace where he choked and threatened her. Three days later, Armstrong and his wife quarreled when he commenced striking her in the head with a hammer in front of his children. His assault was thwarted District Attorney Mary Thornton.

by his twelve year old daughter, whose courageous actions distracted him long enough to allow her mother to escape to a neighbor's residence.

Following the trial, Armstrong's attorney, Steven Geringer, brought a motion to have the case reheard. The motion was addressed yesterday and denied by Judge David Miner. Miner then sentenced Armstrong to 29 years and 4 months in state prison for his two separate actions.

According to District Attorney Keitz, "Events of domestic violence undermine the fabric of family life and our society. The District Attorney's Office takes domestic violence seriously. This was a very tragic case."

A 38-year-old Madera woman sits behind bars facing embezzlement charges, accused of stealing student fundraising money.

Victoria Macias Perez, employed as an Administrative Assistant at Eastin-Arcola High School, located on Avenue 8 in Madera County, faces two counts of felony embezzlement. She's accused of stealing nearly \$3,000 from an account that holds funds raised by the continuation students.

According to Reports, Deputy Sheriff Robert Blehm was dispatched to the high school late Friday crepancy in the account. works. \$690 appeared to be missing. Perez, who handles deposits and withdrawals, was questioned and she reportedly admitted to writing a check to herself in that amount

about what to do in the event you become separated.

Always have your keys in your hand when returning to your vehicle.

Protecting you from online scams:

Beware of high-tech scams such as phony e-card greetings. If you receive an e-mail card and are advised to download the latest software to view it, don't do it. You may be giving someone complete access to your computer.

Phony lottery or sweepstakes notices that you're a winner. You get an email or phone message suggesting you visit a website or return the call to collect your prize. Don't respond. Delete the message.

Phony sales found online. Whether it's eBay, Craigslist or any other venue, do your homework and find out if the company hosting these ads is legitimate.

Protecting your home:

Create open lines of communications with neighbors and businesses within your immediate area.

Take outgoing mail and packages to the post office or courier. When away at the holidays, request that the post office hold your mail delivery and ask your neighbors to retrieve and hold

packages that may be delivered to your home.

Consider installing motion-detector lights around the outside of your home. Light timers also help if you're away and when home. Lights often provide a deterrent, keeping would-be thieves at bay.

When at home or away, always draw your shades to keep outsiders from looking in and previewing what and who's inside.

Keep windows and doors locked at all times. If you need to leave an extra key, don't leave it in a flower pot or under the mat - leave it with a neighbor you know you can reach.

Secure all doors with quality deadbolts and add bolts such as a deadlatch to all windows and sliding glass doors.

Vehicles stored in the garage should be locked at all times. Don't ever keep those keys in plain view.

Motion detectors can also serve as a deterrent. Set up timers to run at random inside your home which will the impression that someone is home.

If you go on vacation, Citizens on Patrol conducts house checks. If you can't reach a neighbor, call the Sheriff's Department, but also let neighbors know if and when you may be gone. If a strange vehicle is seen in your driveway, neighbors will know to call 911.
